

Univ.-Prof. Dr. Harald Eberhard is working as Professor for Constitutional Law at the Department of Constitutional and Administrative Law at the University of Vienna since 2023.

Professor Eberhard passed his law studies in Vienna from 1997 to 2002 and earned his doctorate in law at the University of Vienna Law School in 2002 for his work about public administrative treaties (*Der verwaltungsrechtliche Vertrag*, Springer ViennaNewYork 2005). After that, he started his scientific carrier at the Department of Constitutional and Administrative Law of the University of Vienna Law School. In 2010, he received his habilitation (PhD) from the University of Vienna for his analysis of the non-territorial self-government bodies (*Nichtterritoriale Selbstverwaltung*, Verlag Österreich Vienna 2014). Harald Eberhard also has been working for several years (from 2008 to 2011) at the Austrian Constitutional Court at which he established – as a member of the steering committee – a department for scientific matters. Before joining the WU as a full professor, he held a visiting professorship at the Institute of Austrian and European Public Law (IOER). From 2011 to 2023, he worked as Professor for Public Law at the Institute for Austrian and European Public Law (IOER) at the Department of Public Law and Tax Law of the Vienna University of Economics and Business (WU Vienna). From 2014 to 2022, he held the function of the Programme Director of the Bachelor Law Studies at the WU. From 2022 to 2023, he was the head of the Institute for Austrian and European Public Law. He held – besides the University of Vienna– lectureships at the Vienna University of Economics and Business and the Babeş-Bolyai University Cluj (Romania).

Harald Eberhard is – together with Christoph Bezemek and Claudia Fuchs – Editor-in-Chief of the Vienna Journal on International Constitutional Law (ICL-Journal) which was founded in 2007 (Verlag Österreich/ since 2017 De Gruyter). He also is co-editor of the “International and Comparative Public Law Series” (Facultas/NOMOS Verlagsgesellschaft) which seeks to develop critical and reflexive perspectives on the internationalisation and globalisation of public law, not only in Europe but throughout the world, and of the “Austrian and European Public Law Series” (Verlag Österreich). Furthermore, he holds the editorship of the Austrian Journal for Administrative Sciences (ÖVwBl) and the SIAK-Journal (Journal for Police Science and Practice) as well as the membership of the Scientific Advisory Board of the “Zeitschrift für Verwaltung” (Journal on Administrative Law – ZfV) and “Spektrum der Rechtswissenschaften”. Harald Eberhard also is Vice President and member of the steering committee of the Austrian Society of Administrative Sciences (ÖVG) and of the executive committee of the Austrian Society of legislative matters (ÖGGL) as well of the International Association of the “Interdisciplinary Association of Comparative and Private International Law” (“Interdisziplinäre Gesellschaft für Komparatistik und Kollisionsrecht” – IACPIL/IGKK). Furthermore, for several years he was member of the Coordination Board as well as of the Joint Managerial Committee of the China-EU School of Law (CESL).

The research interests of Harald Eberhard focus in special on the crossroads of constitutional and administrative law both of the national, especially Austrian, and the international level. In his in around 300 publications, Harald Eberhard deals with all relevant topics of constitutional and administrative law as well as public business law and their relation to European Union Law. He is co-author of one of Austria's well-known textbooks in the field (Öhlinger/Eberhard, *Verfassungsrecht [Constitutional Law]* 13rd ed, 2022).

A special research interest is dedicated to the topic of international and comparative constitutional as well as administrative law.
